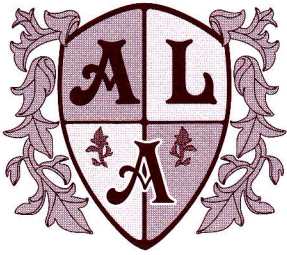

## Admissions Procedures

**Pre-School – 3 year olds** (must be 3 by October 1<sup>st</sup>)

**Pre-School – 4 year olds** (must be 4 by October 1<sup>st</sup>)

\*Parent/Guardian must complete all application forms.  
(\$100 non-refundable application fee must be included)

\*Medical requirements must be met and documentation (medical records form A45) must be submitted along with a copy of an official birth certificate.

\*Any information pertaining to learning, emotional or social abilities including doctor's reports or child study team evaluations should be disclosed.

\*Upon receipt of the above registration becomes final.

**Elementary:** Kindergarten (5 year olds) – 6<sup>th</sup> Grade

\*Parent/Guardian must complete all application forms.  
(\$100 non-refundable application fee must be included.)

\*Foundation Fee of \$275.00 (which includes books, texts, standardized testing, insurance and technology) must be paid by June 1<sup>st</sup>.

\*All transcripts, prior report cards and standardized testing must be received by our office in a timely manner.

\*Any medical evaluations pertaining to your child should be disclosed.

\*Any state or child study team evaluation from your child's previous school should be disclosed.

\*Medical records must be submitted along with a copy of an official birth certificate and all requirements met.

\*An assessment test may be required by administration before registration is final.

**Junior High**

All of the above are required. Administration may require the following:

-placement testing and/or interviews with both, parents and prospective student.

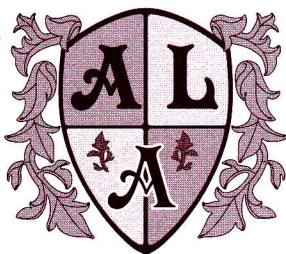


## **High School:**

**\*Students applying for HS must complete all of the above requirements and must have attended ALA for Middle School grades. ALA does not recruit High School students but rather provides a small, individual college preparatory program for students whose parents choose to continue enrollment beyond grade 8.**

**\*The administration may deny re-enrollment for specific academic or disciplinary reasons, or if the needs of the student cannot be met by the existing program.**

- 10 payments (through FACTS, a tuition acquisition company) starting in August and ending in May.

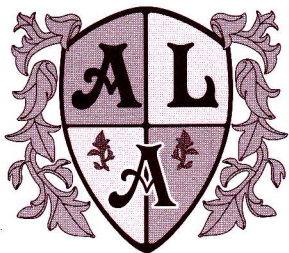
Anyone who brings a new family who registers as a new student at

**PARENTAL COVENANT AGREEMENT**

**In this agreement between ABUNDANT LIFE ACADEMY SCHOOL and**

1. We understand the general philosophy of Christian education, and are in agreement with the purpose and intent of Abundant Life Academy.
2. We agree to uphold and support the high academic standards of the school by providing a place at home for our child(ren) to study and to give our child(ren) encouragement in the completion of homework and assignments.
3. We understand and agree to the following financial policy:
  - A. Tuition is charged by the year. In order to accommodate the student who enrolls after the beginning of the year, tuition will be prorated. In the event that a student withdraws during the school year, the parent/guardian is responsible for the academic year's tuition and fees **to be paid in full.**
  - B. Tuition is an annual fee. For your convenience we offer 3 options to pay tuition:
    1. Payment in full, due by first day of school. (4% discount)
    2. Two half payments due in September and January.
    3. Ten payments through enrollment in tuition acquisition company.  
The first tuition payment is due in August. There are ten (10) payments due each month from August through May. Students whose accounts remain delinquent will not be able to attend classes unless arrangements are made through the business office. A late fee is added on delinquent accounts. All bank fees for check returns and/or miscellaneous fees are to be paid in full by parent/guardian.
  - C. All tuition and fees for the entire school year, regardless of whether paid up front, or under the monthly payment plan are *due and owing and are non-refundable.*
4. We will support the school by: **involvement** in school-sponsored meetings and activities, **volunteerism** when necessary with lunch programs, fundraisers, etc. and **participation in fundraising** since tuition does not cover the entire cost of our child(ren)'s education. Therefore, we will support a required fundraising commitment of \$400.00 per family or opt for the \$200.00 buyout program.

5. We give permission for our child to take part in all school activities, including bus trips, sports activities and school sponsored trips away from the school premises. All school rules apply on all field trips.
6. We understand that the standards of Abundant Life Academy do not tolerate disrespect to the personnel of the school or continued disobedience to the established policies of the school.
7. We acknowledge that there may be times when we must partner with the school in disciplining our children and agree to work with teachers and staff to honor all school policies as outlined in the most current ALA School Handbook. We understand that Abundant Life Academy will NOT administer physical discipline.
8. We understand that assessments will be made to cover damages to the school, including breakage of windows and abuse of other personal property whether intentional or accidental. Abundant Life Academy is not responsible for lost, stolen or damaged property.
9. We will faithfully support the school through our prayers and positive attitude and will not share any complaints, questionable or negative comments (regarding administration or faculty) around our child(ren) or other parents.
10. We understand that failure of the parents of children to comply with the established regulations and discipline, Parental Covenant Agreement and financial obligations, will forfeit the student's privilege of attending Abundant Life Academy.
11. We understand that programs are offered for care outside of school hours and do agree to abide by the policies and procedures as set forth in our Handbook.
12. Abundant Life Academy admits students of any race, color, national and ethnic origin.

We will read the entire Handbook and Covenant Agreement above and agree.
